## Privacy Statement

### **Introduction**

SALIHIN International ("SALIHIN," "we," "our," or "us") is committed to protecting the confidentiality and privacy of the personal data entrusted to us. This Privacy Statement outlines how we collect, use, disclose, and protect your personal data when you interact with us through our websites, events, services, and other communication channels.

We aim to collect only the personal data that you voluntarily provide or that is necessary to deliver our services effectively. We encourage you to read this Privacy Statement carefully to understand our practices regarding your personal data and how we handle it.

### **Scope of this Privacy Statement**

This Privacy Statement applies to all personal data collected by SALIHIN International through:

5. **Public Interest or Official Authority:** Processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in us.

#### **Information You Provide Directly**

We collect personal data that you voluntarily provide to us, which may include:

- **Substantial Public Interest:** Processing is necessary for reasons of substantial public interest, based on applicable laws.

We advise you to exercise discretion when providing sensitive personal data and to refrain from providing such information unless it is necessary for the intended purpose and you consent to its use.
